1. <u>Property Conveyance: Lease agreement for encroachments in to the public right-of-way at 226 E 500</u> <u>S</u>

Consider requesting that the Administration hold a hearing regarding a lease agreement for the encroachment of balconies, two stairs with handrails, and landscaping improvements located on the 500 South side of the Library Square Condominiums. (W 04-4)

2. <u>Property Conveyance: Lease agreement for encroachments in to the public right-of-way at 324 South</u> <u>State</u>
