CURRENT BOARD COMPOSITION:

In part, the <u>Salt Lake City Code</u> states that each voting member "shall be a resident of the City interested in preservation and knowledgeable about the heritage of the City." City code also requires members be selected to provide representation from the following groups of experts and interested parties: (a) a licensed architect representing the American Institute of Architects; (b) a member representing the Utah Historical Society; (c) a member representing the Utah Heritage Foundation; (d) six citizens at large; and (e) a member representing each historic district in the City.
