The Transportation Division is housed within the Community Development Department. The division is responsible for providing the following services:

- 1. Investigates internal and public requests to modify traffic controls on City streets.
- 2. Monitors and maintains streetlights.
- 3. Coordinates traffic signals.
- 4. Issues residential parking permits and administers the residential parking permit program.
- 5. Reviews and approves right-of-way geometric designs of streets.
- 6. Reviews and approves construction barricade plans and parking meter bagging permits.
- 7. Provides transportation planning services for the Planning Commission, Transportation Advisory Board, Mayor's Bicycle Advisory Board, Board of Adjustment, property owners and developers.

Following the division's presentation, the Council may wish to ask the following question:

1. What is the status of the information to be provided to the Council outlining the current street lighting programs and providing recommendations for the neighborhood street lighting plan? (This was requested by the Council in an effort to reduce public confusion about the programs available for street lighting.)

Council staff has provided a four-year budget history for the Transportation Division below.

\*The decrease in budget for FY 04-05 was primarily due to accounting for \$900,000 of streetlight electric charges in the Nondepartmental account rather than in the Transportation Division.

- A. A list of functions / services performed by the Division and an organizational chart, including the number of FTE's.
- B. Information on any service level measurements available (for example, x number of permits were issued last year, a 2 percent increase / decrease over the previous year).
- C. Responses to the following questions:
  - 1. What successes has your Division achieved in the recent past, and what successes do you see in the near future?
  - 2. What are the most significant challenges the Division will face in the near future?
  - 3. Have the services provided by the Division increased / decreased or remained the same over the past 2 or 3 years, and do you anticipate that service levels will increase, decrease, or remain the same in the near future?
  - 4. Are there service level improvements that could be made in your Division with a minimal investment of funding, or are there functions where additional resources may be needed in order to maintain current service levels?


