SUBJECT: **Sticker placement correction to ordinance granting free parking to alternative fuel, clean air, and fuel efficient vehicles**

In December 2005, the City Council adopted an ordinance granting free metered parking to certain fuel-efficient and low-polluting vehicles. The ordinance required a parking permit sticker to be displayed on the vehicle. According to the adopted ordinance, the sticker is to be affixed to the "bottom of the driver's side of the front windshield." City Administration would like to change where the parking permit sticker is displayed on vehicles to better assist parking enforcement with vehicle identification and to make the sticker more visible to other motorists to help advertise the program.

The proposed amendment provides that the parking permit sticker is to be affixed to the bottom of the driver's side of the "rear window" of the vehicle. Current sticker recipients have been informed to place the sticker in the rear window. The Council may wish to consider this revision a housekeeping item.

DISCUSSION:

Issue Origin: The City recently adopted ordinance 12.56.205 which permits "Green Vehicles" to park for free at City parking meters. Subsection B2 of the ordinance requires the recipient of a "Green Vehicle" sticker to affix it to the driver's side of the front windshield of a vehicle.

Analysis: City Administration would like to change where the "Green Vehicle" parking permit sticker is displayed on vehicles to better assist parking enforcement with vehicle identification and to make the sticker more visible to other motorists (helping to advertise the program). The Administration recommends that the sticker to be placed on the bottom of the driver's side of the rear window.

All sticker recipients have already been informed to place the sticker in the rear window. Parking Enforcement concurs in this proposed amendment.

AN ORDINANCE AMENDING SUBSECTION B2 OF SECTION 12.56.205, *SALT LAKE CITY CODE*, PERTAINING TO FREE METERED PARKING FOR ALTERNATIVE FUEL, FUEL EFFICIENT AND LOW POLLUTING VEHICLES.

Be it ordained by the City Council of Salt Lake City, Utah:

SECTION 1. That Subsection B2 of Section 12.56.205, *Salt Lake City Code*, pertaining to free metered parking for alternative fuel, fuel efficient and low polluting vehicles be, and the same hereby is, amended to read as follows:

12.56.205 Parking Meters – No Charge for Alternative Fuel, Fuel Efficient and Low Polluting Vehicles.

B. 1. The Division shall issue a vehicle windshield sticker to all persons applying for such sticker who provide evidence acceptable to the Division that the vehicle for which the sticker is desired is a Fuel Efficient Vehicle or a Low Polluting Vehicle as defined in subsection A of this Section. Motorcycles and other vehicles that are not automobiles shall not be issued a sticker pursuant to this Section.

2. The recipient of the sticker shall affix it only to the bottom of the driver's side of the rear window of the vehicle for which it is issued so that it is readily visible.

SECTION 2. This ordinance shall take effect immediately upon the date of its first publication.
