DISCUSSION:

Issue Origin: As per Section 20A-5-602, <u>Utah Code Ann.</u>, 1953, as amended, requires that at least 15 days before the date scheduled for any local election, the municipal legislative body appoint or provide for the appointment of poll workers.

Analysis: Salt Lake County, as the contracted election officer for Salt Lake City, has submitted this list of poll workers that will be used for Salt Lake City's 2009 Municipal Elections.

Recommendation: That the Resolution be placed on the City Council's consent agenda to approve the appointment of poll workers for the 2009 Municipal Elections.

RESOLUTION NO. OF 2009 APPOINTING POLL WORKERS FOR THE 2009 SALT LAKE CITY MUNCIPAL ELECTION

WHEREAS, Section 20A-5-602, <u>Utah Code Ann.</u>, 1953, as amended, requires that at least 15 days before the date scheduled for any local election, the municipal legislative body appoint or provide for the appointment of:

- (1) four registered voters, or three registered voters and one person 17 years old who will be 18 years old by the date of the regular municipal election, who reside within the county to serve as poll workers for each voting precinct; and
- (2) at least one registered voter who resides within the county to serve as canvassing judge, if necessary, and
- (3) as many alternate poll workers as needed to replace appointed poll workers who are unable to serve; and

WHEREAS, this Council desires to comply with said statutory mandate and to appoint poll workers as required by law for the 2009 municipal election which is scheduled to be held more than 15 days from the present date; and this Council has determined that a canvassing judge is not necessary in this instance;

NOW THEREFORE, BE IT RESOLVED by the City Council of Salt Lake City, Utah, that those persons whose names, addresses, voting precincts, and telephone numbers are set forth on Exhibit "A" attached hereto are hereby appointed to serve as poll workers during the 2009 Salt Lake City municipal election. Exhibit "A", which was prepared by or under the direction of the City Recorder, may be changed as needed without further Council action and is made a part thereof by this reference. Exhibit "A" shall be made available for inspection, examination, and copying during business hours at the office of the City Recorder.
