### TENTATIVE COUNCIL ALLOCATIONS

At the August 18 Council Work session, the Council tentatively allocated non-debt service CIP funds for projects. The following chart shows the breakdown by project type, comparing the CDCIP Board, the Mayor, the Council, and the CIP 10 Year Plan's recommendations.

Attached is the full CIP Log, showing each project allocation as recommended by the CDCIP Board, the Mayor and the Council. The Council can reconsider any of these allocations at any time until formal adoption. The Council does not need to adopt this set of allocations until the September  $22^{\rm nd}$  meeting.

#### FOLLOW UP INFORMATION

A number of follow-up items were requested by the Council at the previous briefing.

- A. **Tennis Courts** Attached is a comprehensive list of all outstanding tennis court rebuild/refurbish projects outstanding in the City. The total cost is \$5.56 million. Of that \$3.74 million is "high priority" (red). If the Council were to bond for the full \$5.56 million (assuming 4%, 20 year term, 1% cost of issuance) the annual debt service would be approximately \$413,206. Debt service on only the high priority projects would be \$277,948.
- B. **City and County Building Fire Control Panel/Sprinklers** The Administration is continuing to review the fire sprinklers situation and recall information with the City Fire Marshall and the City Attorney. At the time of the printing of this staff report, no further information is available. Information may be available for Tuesday's briefing.

#### FY 2010 MATTERS AT ISSUE

A. The Council may wish to request from the Administration information on the year-end budget and current revenue projections before finalizing CIP. Note: If the Council adopts CIP on September 22<sup>nd</sup>, a projection of revenues will be available in conjunction with the Budget Amendment #1 briefing, also scheduled for September 22<sup>nd</sup>.

B. The North Temple Boulevard and Viaduct projects could have a significant impact on CIP and possibly Class C funds in future years, neither of which is contemplated in the current CIP 10 Year Plan. The Council may wish to determine how best to keep those conversations in context with the CIP so that we can avoid the problem of unintended consequences on future CIP budgets.

### **ON-GOING POLICY ISSUES**

- A. A number of policy issues were raised at the August 18th briefing. The Council may wish to review and consider some of these policy issues as guiding principles for the FY 2011 CIP process. The Council may also wish to formulate policy statements to be incorporated into the list in section B (list of current council policies related to CIP).
  - 1. Time sensitive projects out of context Council Members raised the concern that approving "time sensitive projects" out of context with the rest of CIP projects is not beneficial to the Council. While the full list of CIP projects is provided to the Council during the budget, the implications of early decisions cannot be felt until the Council is considering all applications at once, as funding becomes even more limited. The Council could consider the following options:
    - a. Approve no time-sensitive projects except debt service.
    - b. Commit to review CIP by the end of September (so City Departments know what timeframe they can expect to bid out contracts).
    - c. Review and adopt the full CIP list in conjunction with all other department budgets in May and June (may require an additional meeting or later meetings).
  - 2. Use of Class C funds and "Early" approval of Class C funds during budget amendments Council Members raised the concern that as funds get tighter, the City will likely need to rely more heavily on creative sources of funding for projects not traditionally funded with Class C (that are class C eligible). Council staff is gathering more comprehensive information about the exact guidelines for usage of Class C funds, but the Council may wish to consider establishing a policy of not approving Class C funds early in the budget amendment process, in order to provide maximum flexibility and context for the larger CIP process.
  - 3. CDBG Funds The Administration is preparing a document for the Council outlining the federal intent of CDBG funds. The Administration did note to Council Staff that each year they are required to report the amount of CIP funds that were spent in CDBG eligible areas, and that the federal government emphasizes that CDBG funds must be used as a supplement rather than a supplant.
  - 4. Impact fees Impact fees are collected for roads, police, fire and parks. Eligible projects must appear on the 10 year plan, and are scattered throughout the City (fire stations, parks, trails, roads etc).
    - a. Impact fees can only be used for the portion of the project that is directly related to growth. For example, if 5% of a new fire station is needed because of growth, then impact fees can only be used to pay for 5% of the project. Other funds need to be identified for the remainder of the project. If other funds cannot be identified and the project cannot be built, and other projects in that category also cannot be built, then those impact fees must be returned.
    - b. Impact fees for roads are only collected in the Westside industrial area, and can only be spent in the Westside industrial area. Because the road projects identified in that area are not ever 100% growth-related, other funds must be identified to complete the project before funds must be returned.
    - c. Impact fees for Police, Fire, and Parks are collected throughout the City and can be spent throughout the City as long as they are spent on a project that is related to growth (Example Liberty Police Precinct is 7.5% growth related, therefore eligible for 7.5% in impact fees, once they are collected).
  - 5. 10 Year Plan Council Members have expressed an interest in reviewing the 10 Year Plan in conjunction with the Election cycle. The Administration is planning on the process starting at the end of 2009, which would coincide with Council elections. However, they have indicated that a full review of impact fees every 2 years may be cost prohibitive (impact fee studies are required to

be conducted by an outside, certified consultant, per state statute). The Council could choose to review only non-impact fee related projects every 2 years.

The following is a list of current council policies relating to CIP (adopted over the years):

- Establish a formal multi-year capital program
- Link the 10-year needs list and the annual capital budget
- Identify the extent and cost of deferred maintenance
- Utilize condition information to select and prioritize capital projects
- Focus attention on the long-term implications of capital decisions
- Identify full life cycle project costs
- Prepare multi-year revenue and expenditure forecasts
- Give priority to capital improvement projects that reduce current City maintenance requirements.
- Continue taking advantage of one-time opportunities to supplement base budget CIP (i.e. one-time revenues, particularly from the sale of real property).
- Maintain a capital improvement prioritization process that allows citizen and community input.
- Provide ongoing funding to address capital improvement needs of the City.

The previous information was provided on August 18, 2009. It is provided again for your reference.

#### CAPITAL IMPROVEMENT PROGRAM – ALLOCATION OF REMAINING FUNDS

In the budget adopted in June 2009, the Council allocated a total of \$21,593,749 of General Fund dollars and \$2,900,000 of Class C Funds to the Capital Improvement Program budget. At that time, the Council made some funding allocations for projects that were time-sensitive (\$2.3 million in general fund money, and \$2.5 million in "Class C" Road Funds), as well as required debt service payments (\$14.9 million), earlier this summer. Therefore, there is **\$4,424,142** left to allocate from the general fund (which can be used for any capital project), and **\$390,000** left to allocate from "Class C" Road Funds (which are limited to road and sidewalk improvement projects). The following are projects that the Council has already appropriated funds for:

→ Council Staff has attached a log of all 73 project funding requests. For information on how these projects relate to the adopted CIP 10 Year Plan, as well as other Master Plan and policy concerns, please refer to the previous staff report, provided for your reference starting on Page 3. At the Council briefing, staff will walk through the spreadsheet and calculate the balance, as the Council walks through funding decisions.

#### **COUNCIL-INITIATED PROJECTS:**

Since the budget was presented to the Council a few projects have brought to the attention of various Council Members. These items have been listed at the end of the attached CIP log for Council consideration:

- 1. Sugarhouse Streetcar Project Consulting Services for Grant Funds The Administration has indicated that it would be in the best interest of the City to dramatically speed up the work on the Sugarhouse Streetcar Project in order to take advantage of the Transportation Investment Generating Economic Recovery (TIGER) grant funding, authorized by the Federal Stimulus program. In order to qualify for these funds, a detailed application containing a resolution committing to a local match must be completed by September 15, 2009. The Council has been generally briefed on this topic and on the resolution as the RDA Board at the August 11th Meeting. For more detailed information on this project, please see memo prepared by Russell Weeks, for the August 18th Council Meeting.
  - a. In order for the City to complete a competitive application in the given timeframe, the Administration is recommending using the City's current consultants, and sharing the costs with UTA and South Salt Lake. The City Budget and the RDA would split Salt Lake City's portion.
  - b. The City's total commitment is \$126,149, to complete both the TIGER application and the required environmental assessment.
  - c. The City Budget and RDA would split this amount meaning the City would be responsible for \$63,075.
  - d. The Administration will be recommending that this amount come from Contingency (\$24,511), and from delaying a to-be-determined project by \$38,564. They will have this information in time for the Council briefing on Tuesday night. It is the intent of the Administration to "refill" this project at the time of the first Budget Amendment with the existing CIP cost overrun account (which currently has a balance of \$296,747 after recaptured funds are approved). The existing CIP cost overrun account cannot be appropriated for a new project without a formal budget amendment process.
- 2. **North Temple Viaduct** A number of issues have been identified with the North Temple Viaduct rebuilding project, specifically relating to identifying the actual cost of the viaduct, and options affecting the cost. Council Members have indicated initial support for the City to retain an outside consultant to review UTA's cost estimates. The Administration does not have a firm idea of what this would cost. The Council may wish to consider adding funding to this line item.
- 3. **900 South, 700 East to Windsor Street (850 East) Curb & Gutter improvements** This section of 900 South lies in between two previously-constructed City projects, the 900 South storm drain project (west of 700 East), and the 9th and 9th Intersection/Neighborhood project, which starts East of Windsor Street. The original scope of the 9th and 9th project contemplated improving sidewalk and gutter on this western portion of 900 South, but due to

budget constraints caused by increases to project scope at the 9<sup>th</sup> and 9<sup>th</sup> intersection, the length of sidewalk improvements was reduced.

- a. This section of sidewalk and gutter is in significant disrepair. The Administration had previously indicated to the neighborhood that they would submit a CIP application to finish this small section of sidewalk and gutter.
- b. Due to other priorities taking a higher precedence, the Administration did not submit an application for the FY 2010 CIP process, and instead indicated that they would seek FY 2011 Class C funds in the December budget opening.
- c. Council Member Garrott has indicated a preference to fund this project as soon as possible and has asked that it be considered for funding in the FY 2010 CIP process.
- d. Council Staff has inquired with the Administration regarding cost estimates, but as of the printing of this staff report has not yet heard anything.

# POTENTIAL MATTERS AT ISSUE

- 1. The City has three new major funding projects on the immediate horizon, that may require allocation of significant CIP Funds or a commitment of debt service to be paid out of CIP: Sugarhouse Streetcar (local match could be \$2.5 million or higher), North Temple Boulevard Improvements (funding gap could be \$10-\$15 million), and the North Temple Viaduct (funding cap could be \$10 million or higher). Staff note: none of these "gap" estimates have been finalized by the Administration. Staff is listing the estimates to give the Council a broad understanding of the scope of the potential funding commitments on the horizon.
  - a. Before concluding the CIP discussion, the Council may wish to consider funding resources for those project in context with this year's CIP as well as with the City's 10 Year Plan, particularly as it relates to required maintenance and upkeep of City facilities.
  - b. During the FY 2010 budget process the Administration indicated that they would be recommending a new CIP 10 Year Plan sometime in the new year, given the need to update the City's impact fee projects and costs. The Council may wish to re-evaluate the 10 Year Plan as a whole at that time or before that time, given these large projects on the immediate horizon.
- 2. During the Public Safety Complex discussion, the Council discussed building an East Side Precinct/Fire Station at some point in the near future. A funding source for this has not been identified, although \$3.4 million is listed in the 10 Year Plan (FY 2011) for renovating the existing fire station.

The previous information was provided on June 6, 2009. It is provided again for your reference.

# CAPITAL IMPROVEMENT PROGRAM BUDGET RECOMMENDATION

The Mayor presented his budget for Fiscal Year 2009-2010 on Tuesday, May 5. The following staff report details the proposed Capital Improvement Budget.

The Administration recommends funding CIP from the general fund in the amount of \$20,875,982. Of this, \$7,826,123 is slated for general obligation bond debt (dedicated property taxes). Therefore, a total of \$13,049,859, or 7% of general fund revenue, is proposed for Capital projects. Of this amount, \$6,340,361 is pledged for non-GO debt service (including debt service for the TRAX extension and Grant Tower Realignment projects, as well as a new debt service

payment for the Fleet Facility sales tax bond). Therefore, a total of \$6,709,498 is available for non-debt service projects (down from \$656,232 for "other" projects in FY 2009).

The CIP 10 Year Plan (adopted January 2006) indicates that in order for the capital projects to be fully funded over the 10 year cycle of the plan, an average of 7.95% of general fund revenues should be dedicated each year to capital projects. In order to reach the 7.95% number, the Council would have to increase CIP funding by \$1.9 million over the Mayor's recommended budget.

The CIP 10 Year Plan acknowledges that 7.95% of general fund revenue will not be sufficient to fund all projects in every year, but rather – over the 10 year period, if 7.95% is consistently dedicated every year, this will eventually cover all of the projects. In the past, the Council had a stated policy of dedicating a minimum of 9% of general fund revenues for Capital projects. In Fiscal Year 2010, the plan identifies \$8.8 million in non-debt service projects, well over the current funding proposal of \$6.7 million. In addition, a total of \$10.9 million worth of projects that were identified from FY 06-08 in the CIP 10 Year Plan, have not yet been funded.

The Council may wish to consider the policy goals identified at the 2008 retreat when considering project prioritization (see page 10). For more information on the overall CIP budgeting process, see section beginning on Page 11.

### **KEY ELEMENTS**

Attached is a complete log of all CIP project applications for the Council's consideration, along with the Mayor and Community Development and Capital Improvements Program Board (CDCIP) recommendations.

Seventy-Three (73) non debt-related projects were submitted through the regular CIP process for funding. The CDCIP Board reviewed these applications and then made recommendations to the Mayor. For time-sensitive projects that will be discussed at the Council's June 2 work session briefing, see Item E.

The Administration considered all projects together, with the general fund and Class C funds as eligible funding sources. This differs from the previous approach of considering Class C projects separately.

Of these projects, twenty (20) were recommended for funding from the general fund and Class C funds by the Administration, for a total of \$6,709,498 from the general fund, and \$2.9 million from Class C fund. The following chart shows a breakdown of funding totals, by type of project:

The following are key points in relation to the FY 2010 CIP Applications and funding rankings:

- A. The Mayor has taken into account rankings from the CDCIP Board, and has separately ranked all projects. He has recommended funding for project numbers 1-20 (see attached log).
- B. Of the 73 CIP projects, 33 projects are not specifically listed in the CIP 10 year plan. The total request amount of these projects is \$11 million, of which \$3.1 million is recommended for funding by the Mayor.

If the Council funded all "time-sensitive" projects identified by the Administration (excluding debt service and Council Staff identified projects), the appropriation would total \$6,230,009. This would leave approximately \$479,489 million left to allocate later in the summer.

# F. Selected Projects & Highlights:

- a. **North Temple/Grand Boulevard** The Administration has proposed funding \$2,884,653 from general fund sources for the North Temple/Grand Boulevard project. The Administration acknowledges that this is not the full cost of completing the grand boulevard. However, these funds are identified to be eligible for any aspect of the project in conjunction with UTA's funds. The Administration is working with UTA to finalize both the potential costs and overall project timing.
  - i. The Council may wish to request a more detailed briefing from the Administration on the exact costs, project scope, and timing of the North Temple project.
  - ii. The Mayor's proposed budget also includes \$300,000 in on-going funds in the Non-Departmental budget for the North Temple project. The Council may wish to consider adding these funds to the \$2.9 million recommended in the CIP budget in order to keep funds in the same place. Alternately, the Council could re-appropriate the \$300,000 for

- other general fund purposes, given that the North Temple project is recommended for CIP funding.
- iii. As noted in the unresolved budget issues report, a loan repayment from RDA of \$1.8 million is due to the City. North Temple is one of the projects for which those funds could be considered if the Council determines that the loan should be repaid to the City.
- b. Projects Related to Pedestrian Amenities & Alternative Transportation In late April, some members of the Council who serve on the Transportation Subcommittee sent a letter to the Mayor requesting that the City allocate two-thirds or more of its combined transportation budget, including capital improvement, state and federal resources, and transportation planning funds to support programs such as North Temple, Bicycle and Trails Master Plans, pedestrian amenities and infrastructure, pedestrian signals, traffic calming projects, and needed staff positions such as a trails coordinator. The following details highlights of the Administration's proposed budget in relationship to this request:
  - i. The Mayor has proposed funding a bicycle/pedestrian trail planner;
  - ii. The following chart breaks down the proportion of Class C and General Fund allocations for pedestrian amenities and alternative transportation projects compared to other projects:

When considering non general-obligation debt (general obligation debt payments were not rolled into this calculation because they have a voted upon dedicated revenue source and the allocations cannot be changed), the Mayor's budget proposes to allocate 50.1% of capital funds to pedestrian and alternative transportation projects. When excluding debt projects (as debt service payments cannot be changed), the Mayor's proposed budget dedicates 70.9% of "free" CIP funds to pedestrian and alternative transportation projects. The Council may wish to identify projects on the CIP log that would qualify as pedestrian or alternative transportation projects, that have not yet been funded, and consider increasing the amount dedicated to CIP from the general fund, or identifying projects to shift resources away from that the Mayor has funded. Additionally, as the Council has authority to issue and commit to debt service, the Council may wish to revise its debt policy, and establish a goal for future sales tax or GO bonds to be related to pedestrian or alternative transportation projects. Note: Staff has included the TRAX Extension debt service payment in the category of "Pedestrian

Related" as the City's funds paid for the installation of a station on 200 South in addition to re-building and improving the 200 South sidewalk. Staff can provide a listing of items considered for each category of these calculations and will recalculate the percentages if Council Members differ in the interpretation of the category in which particular projects belong.

- c. **Bicycle Facilities Development** The Mayor's recommended budget includes \$450,000 from the General Fund (*CIP log #15*) for Bicycle Facilities development. This includes, but is not limited to design & construction of bicycle/pedestrian paths, routes & facilities Citywide. It also would include bike racks, restriping lanes for bike use or match for federal funding. The Administration indicates that with the proposed \$450,000 they could install 6 lane-miles of green shared lanes downtown (as seen on 200 South), 4 lane-miles of striped bike lanes (including Main Street downtown to 2100 South), and add 100 bike racks throughout the City.
- d. **Jordan River Trail** The Mayor's recommended budget includes \$650,000 from the General Fund (*CIP log #17*) or completion of the Jordan River trail north of North Temple to the Davis County line.
- e. Fairmont Park Projects Two projects for Fairmont Park were submitted for funding in the FY 2010 CIP process: The Fairmont Park Tennis Court Reconstruction (CIP Log #37 \$733,200 requested), and redesign and construction of the Fairmont Park lake edge (CIP Log #45 \$478,962 requested). Neither of these projects are recommended for funding. The Council has had a preliminary discussion of the Fairmont Park Master Plan, but may want to consider sending the master plan (and therefore these funding requests), through the soon-to-be-created Parks Advisory Board (note: this may delay these projects past the FY 2011 funding application deadline, which is November of 2009). The Council may wish to make a formal request that the master plan be sent through the formal Planning Commission and City Council master plan process for adoption.
- f. ADA Ramps The Mayor's recommended budget includes \$400,000 in funding for Street ADA Ramps/Corner repairs (#1). The CIP 10 Year Plan does indicate that \$400,000 per year should be spent on these projects from the general fund, and \$0 from CDBG. However, during this year's CDBG discussion, the Council funded approximately \$300,000 for this purpose. Therefore, the Council could choose to fund \$100,000 from CIP for this purpose, and redirect the \$300,000 towards other CIP projects that may not be currently funded (though this would restrict construction to CDBG-eligible areas). In recent years the Council has funded ADA Ramps/Corner repairs from both CIP and CDBG funds (\$700,000 total in FY 2008 and \$778,868 total in FY 2007).
- G. The Administration will be available at the Council work session to answer any project-specific questions.
- H. Council Staff will have the complete CIP 10 Year Plan for reference at the briefing. There has been discussion of updating the 10 year plan. The Council may wish to determine whether this is a priority and determine whether funding would be needed for an update.

### **NEW DEBT SERVICE OBLIGATIONS**

- A. The Mayor's recommended budget includes debt service payments for the new Sales Tax bond (issued by the Council in January of 2009) for the Fleet Facility project and acquisition of additional City office space.
  - 1. General fund debt service for the Fleet Facility portion of the project (approximately \$25 million) is estimated at approximately \$1.5 million per year, though the amount slated for FY 2010 is \$520,547 (partial year payment). The

Fleet Fund, Impact Fees, and the Refuse fund would also be also contributing to the payment of these bonds (see schedule below):

- 2. The Council has also added to the bond for the purchase, acquisition and improvement of the previous Barnes Bank building (400 South 300 East). The Administration is continuing to investigate options for renovation and reuse of this building, and will delay requesting the Council issue this part of the bond until such time as the project costs can be finalized.
- 3. If the entire bond was issued, total debt service per year would be approximately \$2.2 million.
- B. 10 Year Plan Implications The CIP 10 Year Plan does have a total of \$1.78 million in *new* debt service (both the Fleet Facility and TRAX/Grant Tower bonds). The amount planned for the Grant Tower/TRAX Extension bonds is \$562,294 per year (more than the current debt service of \$402,955 at the time the 10 Year Plan was contemplating that more of the Grant Tower project would be bonded for), and the amount planned for the *general fund portion* of the Fleet Facility bond is \$1.22 million per year.
- C. Debt Ratio Benchmarking Data The City reviewed data obtained from the various rating agencies in order to benchmark our debt ratio in comparison to other cities in the US. Currently Salt Lake City's debt ratio is \$615 per capita, 0.6% of market value, and represents 8.1% of General Fund Expenditures. The following chart illustrates what credit agencies would consider low, moderate, and high ratios of debt. Salt Lake City's current figures place in the low to moderate range (note: This includes current partial year payment of debt service on the Fleet Facility but does not include bonding for any new projects Barnes Bank Building, Public Safety Facilities, etc).

### POTENTIAL BUDGET-RELATED MATTERS AT ISSUE

A. The Council may wish to separate CIP projects that have been prioritized in the 10 Year Plan from projects that have not been prioritized in the 10 Year Plan. Based on the policy that

- these projects have been identified as on-going needs in the City, they could exclusively be funded with on-going money, while projects that have been suggested outside of the 10 Year Plan, could be funded with one-time money (with the policy basis that "surplus" money will cover "non-essential" projects).
- B. The Council may wish to discuss an option to fund energy-efficiency-related projects with the potential future funds from the Energy Efficiency and Conservation Block Grant (EECBG) or whether they should be covered with the CIP budget and ranked among all other capital projects.
- C. The Council may wish to consider the policy goals identified at the 2008 retreat when considering funding allocations:

D. The Council may wish to clarify with the Administration, the status of the year to year changes in costs of construction materials. Staff has reviewed articles from various publications that indicate that the cost of construction materials is not rising as fast as in recent years, and may even be declining. The Council may wish to request that the Administration provide an update of the most current experience in construction cost changes in Salt Lake City, as compared to recent years, in order to judge a sufficient contingency allocation.

#### BACKGROUND - CAPITAL IMPROVEMENT PROGRAM BUDGET PROCESS

The Capital Improvement Program is a multi-year planning program that uses two main planning documents: a 10 Year Capital Improvement Plan, and each fiscal year's capital budget. The Council adopted a revised 10 Year Capital Improvement Plan, on January 17, 2006, after a lengthy process to identify the most critical and realistic projects that need to be funded over the

next decade. It should be noted that the overall amount to transfer from the general fund in order to pay for this 10 Year Plan over the decade, is 7.95%. Note: 7.95% is the number to be allocated to balance over the 10 year period. If 7.95% of general fund revenue is allocated, there will be some years that will have a surplus and some years that have a deficit. Therefore, if less than 7.95% is allocated one year, this does not weaken the likelihood of completion of the 10 Year Plan, as long as more than 7.95% is allocated in a following year. The Administration plans to revisit this plan later in FY 2010 to keep costs and project priorities current.

Following the Mayor's presentation of his recommended budget on Tuesday May 5<sup>th</sup>, the Council received a schedule of the proposed capital projects for fiscal year 2008-09 with ranking information from the CDCIP Board and the Mayor. The schedule identifies all of the projects that were submitted for funding with the Mayor's recommendations and the priority rankings of the Citizens Advisory Board and Administrative staff. The City Council makes the final determination of projects to be funded. Council staff will project the schedule on the screen during the work session to facilitate discussion and funding decisions.

The Administration accepts applications for capital projects from citizens and City departments each year for consideration for recommendation by the Mayor to the Council for funding. All applications are reviewed by the CIP Citizens Board (CDCIP) and a team of City staffers from each department who specialize in capital projects. Copies of each project application can be made if Council Members desire.

During the past three years, the Council has appropriated funds for debt service and "time sensitive projects" during the annual budget process and waited until later in the summer to make other appropriations. The Council may wish to determine whether it wants to pursue this same coarse of action or whether the Council wishes to appropriate the entire amount of CIP funding for specific projects during the annual budget process.

### COUNCIL POLICIES REGARDING CAPITAL IMPROVEMENT PROGRAM

On April 6, 1999 the City Council adopted a resolution entitled "Council Policies Regarding Salt Lake City's General Fund Capital Improvement Program." This resolution specifically stated the Council's intentions that the Administration regard the resolution as the Council's policy objectives for the City's General Fund CIP Program. In December 1999 the Council adopted a resolution entitled "Salt Lake City Council Capital and Debt Management Policies" which set forth the capital and debt-management policies that were intended to guide the City in addressing the deferred and long-term infrastructure needs of the City. In December 1999, the Council also adopted an ordinance (which was amended in May 2000, and again in 2006 – see section on impact fees below) establishing impact fees on new development within the City. Revenue from these fees are dedicated to fund those capital projects which are directly attributable to growth.

Some of the Council's capital improvement program policies are highlighted as follows:

- Establish a formal multi-year capital program
- Link the 10-year needs list and the annual capital budget
- Identify the extent and cost of deferred maintenance
- Utilize condition information to select and prioritize capital projects
- Focus attention on the long-term implications of capital decisions

- Identify full life cycle project costs
- Prepare multi-year revenue and expenditure forecasts
- Give priority to capital improvement projects that reduce current City maintenance requirements.
- Continue taking advantage of one-time opportunities to supplement base budget CIP (i.e. one-time revenues, particularly from the sale of real property).
- Maintain a capital improvement prioritization process that allows citizen and community input.
- Provide ongoing funding to address capital improvement needs of the City. (Council's policy is that at least 9% of on-going General Fund revenue be allocated to the CIP Fund. Class C, federal funds, impact fees, and one-time monies are all in addition to the 9%. For fiscal year 2004-05, the Mayor proposed a one-time reduction to approximately 7%.)
  - ➤ It should be noted however, that in October 2005, the Council made the decision to revise the 20 Year Inventory of Capital Needs and evaluate spending expectations as compared with recent budget realities. In January 2006, the Council adopted a fiscally constrained 10 Year Capital Facilities Plan, in which each department was asked to identify the most crucial and realistic projects, in order to arrive at a plan that was more likely to be executed to completion.
  - ➤ The consultants hired to form the plan noted that in order to fully pay for the fiscally constrained 10 Year list of projects, the Council would need an average of 7.95% of the general fund per year allocation to CIP (see note on page 2).

## "SPECIAL" ITEMS WITHIN THE CIP BUDGET

#### **Impact Fees**

Impact fees are a financing tool that enables the City to address some of the infrastructure necessitated by new growth without further deferring current infrastructure needs. Impact fees cannot be assessed to address issues of deferred capital infrastructure. Revenue collected from impact fees must be expended or encumbered within six years after receipt, unless the Council identifies, in writing, an extraordinary and compelling reason to hold the impact fees longer. Under such circumstances, the Council must establish an absolute date by which the impact fees will be expended. Impact fees are determined based on future projects in the 10 year plan that relate to new growth. It should be noted that as the Administration and Council revise the 10 Year plan, Impact Fees may be adjusted to reflect new projects.
