JOINT RESOLUTION OF THE CITY COUNCIL AND MAYOR IN HONOR OF THE FIRST 12 CITIZENS WHO RESPONDED TO THE RED BUTTE CREEK OIL SPILL ON

JUNE 12, 2010 AND SIGNIFICANTLY HELPED TO MITIGATE THE IMPACT ON SALT LAKE CITY RESIDENTS AND THE NATURAL ENVIRONMENT

**WHEREAS,** crude oil was discovered spilling into Red Butte Creek on the morning of June 12, 2010; and

**WHEREAS,** response time was critical as the oil continued to leak into the creek; and

**WHEREAS,** 11 workers from Big D Construction were on the job at a construction project nearby; and

**WHEREAS,** one employee from Red Butte Garden was working in the vicinity as a landscape irrigation technician; and

**WHEREAS,** all 12 citizens responded immediately, volunteering at the site of the spill with tractors, backhoes, manpower and the sheer desire to do whatever they could to help contain the oil; and

**WHEREAS,** the Salt Lake City Fire Department gratefully accepted the offers of help; and

WHEREAS, the 12 responders acted quickly and skillfully; and

**WHEREAS,** their heroic response of helping to build a containment area to trap the crude oil significantly reduced the amount of oil that flowed into the creek; and

**WHEREAS,** the 12 responders were not motivated by any financial incentives, rewards or special recognition; they simply knew their service was needed.
