**a. 2:01:45 PM Landscaping Requirement for lots with Billboards. (Councilmember Jill Love)**

Councilmember Love said she wanted the Council to have a briefing discussion about outdoor advertising. Jill, Luke and Søren were interested in advertising at bus stops in order to pay for bus shelters. She said City ordinance requires landscaping of lots with billboards but it doesn't define what landscaping is. Doug Dansie said Planning staff was currently looking sign changes.

**b. 2:12:37 PM Response during emergency situations - Council role, budget etc. (Councilmember Carlton Christensen)**

Councilmember Christensen said Homeland Security offered a two day training course for emergency response costs. He said he would like the Council to look at the City's ordinances regarding FEMA costs, procurement limits and special emergency funding. He said private business continuity could be a problem in an emergency and needed to be looked at. All Council Members present wanted to consult with Cory Lyman, Emergency Management Director.
